Regarding “contaminants” in drinking water:

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. In order to ensure that tap water is safe to drink, the Washington State Department of Health and EPA prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration (FDA) and the Washington Department of Agriculture regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

Sources of drinking water:

Common sources of drinking water—both tap and bottled water—include rivers, lakes and streams (surface water) and wells and springs (groundwater). As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material. The water can also pick up substances resulting from the presence of animals or from human activity.

Reminder:

Any hazardous material that you put onto the ground or in your septic tank could potentially pollute the groundwater. Please help the Forest Park Water System prevent groundwater contamination for this and future generations.

Where does my water come from?

Your water comes from one well and is considered groundwater. The well is 158 feet deep and located on Tract B off of 47th Avenue NE. The water enters the reservoir through a fire nozzle to create spray that drives off naturally-occurring carbon dioxide (CO₂) in the groundwater. This raises the pH of the water, which in turn reduces the water’s corrosivity toward household copper plumbing and fixtures.

Contaminants that may be present in source water include:

- ◆ Microbial contaminants, such as viruses, parasites and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- ◆ Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- ◆ Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- ◆ Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.
- ◆ Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.



Water Quality Data

How To Read The Tables:

Your water is tested for more than 100 contaminants for which state and federal standards have been set. **Tables 1 & 2** list all primary contaminants that were detected (in any amount) along with their respective Maximum Contaminant Levels (MCLs). Primary standards protect public health by limiting the levels of these contaminants in drinking water. **Table 3** shows the levels of secondary contaminants and common water properties of interest to many consumers. Secondary contaminants have no known health effects but can affect the aesthetic properties of water (taste, odor and appearance). Secondary Maximum Contaminant Levels (SMCLs) are guidelines only.

Terms and Abbreviations used:

Maximum Contaminant Level (MCL): the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG): the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Action Level (AL): the concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.

Lead and Copper 90th Percentile Value: Out of every 10 homes sampled, 9 were at or below this level. This must be \leq the AL or additional steps must be taken.

Synthetic Organic Chemicals (SOCs). Because 2008 was the first year in a new 3-year monitoring period, the Dept of Health (DOH) did not schedule any SOC sampling (herbicides, pesticides and insecticides) in 2008 that the water system may receive a monitoring waiver for later. These waivers will be announced by the DOH in 2009. No SOC monitoring is required in the meantime.

^a For systems that collect < 40 coliform samples per month, the MCL is 1 positive (unsatisfactory) monthly sample.

^b Total coliform bacteria are naturally present in the environment, harmless to the general population and used as an indicator that other potentially harmful bacteria may be present. Fecal coliforms and *E. coli*, a subset of the total coliform group, are bacteria whose presence indicates that the water may be contaminated with human or animal waste. Microbes in these wastes can cause short-term effects such as diarrhea, cramps, nausea, headaches or other symptoms. They may pose a special health risk for infants, young children and people with severely compromised immune systems. Coliforms were found in five routine samples collected in Oct 2008, four of which were *E. coli* positive, also. This was concurrent with the *E. coli* event. Details of the Acute (*E. coli*) Coliform MCL Violation in October were provided in notices distributed to customers on 10/10/08 (Boil Water Advisory) and 10/14/08 (Boil Water Rescission). Air-pressurization of the storage reservoir on 10/10/08 revealed a leak at the base of the roof vent which was determined to be the pathway for contamination into the system. It was repaired and re-sealed the same day.

^c The MCL is: A routine monthly sample and a repeat sample are total coliform positive and one of those samples is also fecal or *E. coli* positive.

^d Most recent testing done, in accordance with the regulations (required every 3 years)

^e Equivalent to 5.6 grains per gallon of hardness. 0-75 ppm hardness is considered "soft" water, 75-150 ppm is "moderately hard", 150-300 ppm is "hard" and > 300 ppm is "very hard".

^f The EPA recommends 20 ppm sodium as a level of concern for those who must restrict their dietary intake.

Corrosion Control Treatment Update. We are pleased to report that all ten samples collected at customer taps during the second round of special follow-up monitoring in March 2008 were also below the EPA Action Levels for lead and copper in drinking water. The aeration of the source water upon entry into the storage tank has proven an effective means of reducing the corrosivity of the water toward household plumbing and fixtures. The system is now considered "optimized for corrosion control" by the Dept of Health's Office of Drinking Water.
