Regarding “contaminants” in drinking water:

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. In order to ensure that tap water is safe to drink, the Washington State Department of Health and EPA prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration (FDA) and the Washington Department of Agriculture regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

Sources of drinking water:

Common sources of drinking water—both tap and bottled water—include rivers, lakes and streams (surface water) and wells and springs (groundwater). As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material. The water can also pick up substances resulting from the presence of animals or from human activity.

Reminder:

Any hazardous material that you put onto the ground or in your septic tank could potentially pollute the groundwater. Please help the Foxhall Water System prevent groundwater contamination for this and future generations.

Where does my water come from?

Your water comes from four wells and is considered groundwater. Wells #1 and #2 are 110 and 163 feet deep, respectively, and are located on Tract C in Division 1. Wells #3 and #4 are 145 and 147 feet deep and are located on Tract 15 in Division 3. Your water is not treated (no chlorination, filtration, pH adjustment, etc.)

Contaminants that may be present in source water include:

- ◆ **Microbial contaminants**, such as viruses, parasites and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- ◆ **Inorganic contaminants**, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- ◆ **Pesticides and herbicides**, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- ◆ **Radioactive contaminants**, which can be naturally occurring or be the result of oil and gas production and mining activities.
- ◆ **Organic chemical contaminants**, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.



Water Quality Data

How To Read The Tables:

Your water is tested for more than 100 contaminants for which state and federal standards have been set. **Tables 1 & 2** list all primary contaminants that were detected (in any amount) along with their respective Maximum Contaminant Levels (MCLs). Primary standards protect public health by limiting the levels of these contaminants in drinking water. **Table 3** shows the levels of secondary contaminants and common water properties of interest to many consumers. Secondary contaminants have no known health effects but can affect the aesthetic properties of water (taste, odor and appearance). Secondary Maximum Contaminant Levels (SMCLs) are guidelines only.

Terms and Abbreviations used:

Maximum Contaminant Level (MCL): the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG): the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Action Level (AL): the concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.

Lead and Copper 90th Percentile Value: Out of every 10 homes sampled, 9 were at or below this level. This must be \leq the AL or additional steps must be taken.

ppb: parts per billion. **ppm:** parts per million.

N/A: not applicable **NTU:** nephelometric turbidity unit

Sodium. Neither the EPA nor the WA State Board of Health have established an MCL for sodium but due to concern for consumers who must restrict their dietary intake, your drinking water is monitored for sodium every 3 years. The EPA recommends 20 ppm as a level of concern for those consumers who must restrict their intake. The level of sodium in your drinking water was last measured in 2008 at **6 ppm**.

^a Most recent testing done, in accordance with the regulations (required every 3 years (not all sources are tested in the same year)).

^b There are four wells on this system and each is tested. A range of results is shown if their results differ.

^c For systems that collect less than 40 bacteriological samples per month, the MCL is one positive (unsatisfactory) monthly sample. One unsatisfactory sample does not necessarily pose a public health threat.

^d Coliforms are bacteria that are naturally present in the environment, harmless to the general population and are used as an indicator that other potentially-harmful bacteria may be present. Their presence is a warning of potential problems because disease-causing organisms may also enter the system via the same route as the coliforms. The presence of coliforms usually means that soil or vegetation has entered the system. Details of this July 2008 Non-Acute Coliform MCL Violation and what was done to correct it were provided in a notice distributed to all customers on 8/8/08. The routine sample collected during the month of November was also total coliform-positive. However, multiple follow-up samples collected in response to this positive sample were all absent of coliforms, as were an increased number of routine samples taken the following month (December). All other routine monthly bacteriological samples collected during 2008 were absent of coliforms.

^e Equivalent to 2.8-4.2 grains per gallon of hardness. 0-75 ppm hardness is considered "soft" water, 75-150 ppm is "moderately hard", 150-300 ppm is "hard" and > 300 ppm is "very hard".

^f 1.0 NTU is the state's drinking water response level, meaning additional sampling or steps may be required, if exceeded.

Volatile Organic Chemicals (VOCs). In 2008, your water sources were monitored for 60 different VOCs. These are by-products of industrial processes and petroleum production, and can also come from gas stations and dry cleaners. We are pleased to report that there were no detections, in **any** amount, of any of these contaminants!

Synthetic Organic Chemicals (SOCs). Because 2008 was the first year in a new 3-year monitoring period, the Dept of Health (DOH) did not schedule any SOC sampling (herbicides, pesticides and insecticides) in 2008 that the water system may receive a monitoring waiver for later. These waivers will be announced by the DOH in 2009.
