### Regarding “contaminants” in drinking water:

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. In order to ensure that tap water is safe to drink, the Washington State Department of Health and EPA prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration (FDA) and the Washington Department of Agriculture regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

### Sources of drinking water:

Common sources of drinking water—both tap and bottled water—include rivers, lakes and streams (surface water) and wells and springs (groundwater). As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material. The water can also pick up substances resulting from the presence of animals or from human activity.

#### Reminder:

Any hazardous material that you put onto the ground or in your septic tank could potentially pollute the groundwater. Please help the Green Acres Water Association Water System prevent groundwater contamination for this and future generations.

### Where does my water come from?

Your water comes from one well which is 160 feet deep and is considered groundwater. Your water is not treated (no chlorination, filtration, pH adjustment, etc.)

### Contaminants that may be present in source water include:

- ◆ Microbial contaminants, such as viruses, parasites and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- ◆ Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- ◆ Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- ◆ Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.
- ◆ Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.



**How To Read The Tables:**

Your water is tested for more than 100 contaminants for which state and federal standards have been set. **Tables 1 & 2** list all primary contaminants that were detected (in any amount) along with their respective Maximum Contaminant Levels (MCLs). Primary standards protect public health by limiting the levels of these contaminants in drinking water. **Table 3** shows the levels of secondary contaminants and common water properties of interest to many consumers. Secondary contaminants have no known health effects but can affect the aesthetic properties of water (taste, odor and appearance). Secondary Maximum Contaminant Levels (SMCLs) are guidelines only.

**Terms and Abbreviations used:**

**Maximum Contaminant Level (MCL):** the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**Maximum Contaminant Level Goal (MCLG):** the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**Action Level (AL):** the concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.

**Lead and Copper 90th Percentile Value:** Out of every 10 homes sampled, 9 were at or below this level. This must be  $\leq$  the AL or additional steps must be taken.

**ppb:** parts per billion. **ppm:** parts per million.

**N/A:** not applicable **NTU:** nephelos turbidity unit

**Sodium.** Neither the EPA nor the WA State Board of Health have established an MCL for sodium but, due to concern for consumers who must restrict their dietary intake, your drinking water is monitored for sodium every 3 years. The EPA recommends 20 ppm as a level of concern for those consumers who must restrict their intake. Sodium in your drinking water was last measured in 2007 at 7 ppm.

<sup>a</sup> For systems that collect < 40 coliform samples per month, the MCL is 1 positive (unsatisfactory) monthly sample. One positive sample does not necessarily pose a public health risk. Upon notification by the lab of the positive routine sample in August 2008, four “repeat” samples were collected to **confirm** the presence of coliforms and to determine their source. All four repeat samples were absent of coliforms. Results of additional “investigative” samples collected that same day showed that the coliforms were originating in the storage tank (the well was absent of coliforms). On 8/28/08, the storage tank was drained, cleaned and disinfected. A follow-up sample collected from the tank on 9/9/08 was absent of coliforms, as were an increased number of routine samples collected during the month of September. This confirmed that the coliforms had been eliminated and remained absent from the system.

<sup>b</sup> Your drinking water source was granted a 9-year monitoring waiver for Inorganic Chemicals (IOCs) by the Dept of Health. Only one complete IOC sample is required between January 2002 and December 2010. Eligibility for an IOC waiver depends on source-specific water quality history and a waiver application. The annual sampling requirement for nitrate cannot be waived.

<sup>c</sup> Equivalent to 4.9 grains per gallon of hardness. 0-75 ppm hardness is generally considered “soft” water, 75-150 ppm is “moderately hard”, 150-300 is “hard” and > 300 ppm is “very hard”.

<sup>d</sup> 1.0 NTU is the state’s drinking water response level, meaning additional sampling or steps **may** be required, if exceeded.

**Your drinking water source meets all applicable EPA and Dept of Health standards!**

The Dept of Health (DOH) waived the monitoring requirements for Synthetic Organic Chemicals (herbicides, pesticides and insecticides) during the 2005-2007 monitoring period. This was based on their review of the source’s susceptibility to contamination, well log data and water quality history. Waiver options for the current 2008-2010 monitoring period will be announced by DOH in 2009. No SOC monitoring is required in the meantime.
